What is BAA & BABA



BAA

The Buy American Act (BAA) requires that products purchased for U.S. federal government projects be manufactured in the United States or substantially transformed domestically. In the lighting industry, for a product to be considered compliant, at least 65% of its component costs must come from the U.S., increasing to 75% by 2029.



BABA

The Build America, Buy America Act (BABA) mandates that federally funded infrastructure projects use U.S. made products. For a fixture to be compliant, 55% of the component costs must be manufactured in the U.S. and final assembly must occur domestically.
